## **VOLUNTARY ANNOUNCEMENT BUSINESS UPDATE ON PRODUCTION AND SALE OF PERSONAL PROTECTIVE EQUIPMENT**

This announcement is made by Cabbeen Fashion Limited (the “**Company**”, together with its subsidiaries (the “**Group**”)) on a voluntary basis. The board (the “**Board**”) of directors (the “**Directors**” and each a “**Director**”) of the Company wishes to announce that the Group has commenced the production and sale of medical gowns and medical facial masks (“**PPE**”) since February 2020.

In view of the pandemic of COVID-19 (the “**Pandemic**”) and the Group’s industry reputation and the established capabilities and sound track record in designing and manufacturing garment products, local authorities in Shishi City, Fujian Province, invited the Group to join forces with other entities in the area to produce PPE for hospitals and other organizations in need in the People’s Republic of China (the “**PRC**”). The Directors were of the view that such invitation represented a great opportunity for the Group, as a responsible corporate citizen, to contribute to the society in a very meaningful way by leveraging on its operational expertise. Hence the Group responded to the authorities’ invitation by setting up its PPE production line in February 2020.

By mid-February 2020, the Group has set up its first PPE production line. The Group then started to manufacture and supply PPE to hospitals and other organizations in need in the PRC since then. Since late March 2020 when the Pandemic in the PRC was gradually alleviated, the Group started to sell PPE to overseas purchasers from different countries.

Depending on the development of the Pandemic, the volume of the Group's sale of PPE may fluctuate significantly from time to time. Manufacture and sale of PPE are not expected to be the Group's long-term focus, but such business represents the Group's manifestation of its commitment of social responsibility at a time when PPE is much needed in the PRC and other parts of the world.
